INSURANCE/HEALTH: Provides relative to contracts with dental providers

AN ACT

2	To enact R.S. 22:1157, relative to contracts with dental providers; to provide that no dental
3	plan may require that a dentist provide dental health care services to a covered
4	person at a particular fee unless such services are covered services for which benefits
5	are paid under a contract with such dentist; and to provide for related matters.
6	Be it enacted by the Legislature of Louisiana:
7	Section 1. R.S. 22:1157 is hereby enacted to read as follows:
8	§1157. Dental reimbursement or payments
9	A. As used in this Section, the following definitions shall apply:
10	(1) "Covered person" means any subscriber, enrollee, member, or participant
11	in a dental plan, or his dependent, for whom benefits are payable when that person
12	receives dental health care services rendered or authorized by a licensed dentist.
13	(2) "Covered service" means any dental health care service rendered or
14	authorized by a licensed dentist on a covered person for which the insurer is required
15	to pay benefits to the dentist under a contractual agreement with such dentist.
16	(3) "Dental plan" means any insurance policy, benefit plan, or dental service
17	contract providing for the payment of benefits for dental health care services.
18	B. No dental plan that is delivered, renewed, issued for delivery, or otherwise
19	contracted for in this state may require that a dentist provide dental health care

McVea HB No. 1246

Abstract: Provides that no dental plan may require that a dentist provide dental health care services to a covered person at a particular fee unless such services are covered services for which benefits are paid under a contract with such dentist.

<u>Proposed law</u> provides that no dental plan that is delivered, renewed, issued for delivery, or otherwise contracted for in this state may require that a dentist provide dental health care services to a covered person at a particular fee unless such services are covered services for which benefits are paid under a contract with such dentist. Makes <u>proposed law</u> subject to such contractual limitations on benefits for covered persons as may apply, including but not limited to deductibles, waiting periods, or frequency limitations, but not including a dental plan's total annual maximum for benefits. Defines terms "dental plan", "covered person", and "covered service".

<u>Proposed law</u> provides that the provisions of <u>proposed law</u> shall not apply to contracts already in existence until the renewal or extension date of such contracts.

Effective upon signature of governor or lapse of time for gubernatorial action.

Summary of Amendments Adopted by House

Committee Amendments Proposed by <u>House Committee on Insurance</u> to the <u>original</u> bill.

- 1. Made a technical change.
- 2. Added a provision that prohibits the application of <u>proposed law</u> to contracts already in existence until the renewal date of such contracts.

House Floor Amendments to the engrossed bill.

- 1. Modified the definition of "dental plan" by specifying that it is any insurance policy, benefit plan, or dental service contract providing for the payment of benefits for dental health care services.
- 2. Specified that the provisions of <u>proposed law</u> are not applicable to contracts already in existence until the extension date of the contract.
